

Fantastical Beasties' Waitlist and Deposit Agreement

Fantastical Beasties' Waitlist is honored on a first-deposit, first-choice basis. Waitlist Priority may be given to Adopting Families who indicate their choice to adopt more than one kitten when submitting their Adoption Questionnaire and this Waitlist/Deposit Agreement.

Please read, review, and sign the terms and conditions of this Waitlist and Deposit Agreement.

By submitting this completed form to Fantastical Beasties, I accept and agree to the following:

- I understand that **ALL DEPOSITS** are NON-REFUNDABLE but may be TRANSFERABLE WITH LIMITATIONS. I understand that in the case that I decline a kitten pick/selection, I will be given the option to be placed on the Waitlist for the next expected litter, and my current deposit will be transferred to that Waitlist. However, this transferable option will only be honored for two consecutive future litters, at which time, if a kitten pick/selection is still refused, the deposit will be forfeited. If Fantastical Beasties ceases to breed Maine Coon x Ragdoll Kittens before I receive a kitten from them under these limitations, my Waitlist Deposit will be returned to me.
- I understand that Venmo is the preferred payment method for the Waitlist Deposit. Any and all fees charged by money transfer entities such as Venmo, Paypal, credit cards, etc. are the responsibility of the Adopting Family and will NOT be applied to the final adoption fees.
- I have familiarized myself with the adoption fee ranges listed on the Fantastical Beasties' website, and am prepared to pay an adoption fee within the stated range for the particular kitten(s) I choose.
- I understand that the final adoption fee of the kitten(s) will be determined when the kittens are 4 to 5 weeks old, at which time I will be offered my kitten pick(s)/selection(s), in order of the Waitlist. To choose and secure a particular kitten, an additional 50% **DEPOSIT** (of the remaining balance) per kitten selected must be made via Venmo, Cashier's Check, or Money Order.
- I have received prior approval from any person who may potentially disallow or not be in favor of a kitten/cat living in my home, and do not foresee my living arrangements changing to a situation where I will not be allowed to have a kitten/cat living in my home.
- I understand that although Fantastical Beasties will make reasonable efforts to send updates, it is ultimately my responsibility to be in regular contact with Fantastical Beasties.
- I have thoroughly read and understand the adoption process clearly outlined on the Fantastical Beasties' website and have requested and received answers to any questions.
- I will provide the balance of the final adoption amount due (by cash, certified check, or money order only) for the chosen kitten(s) to Fantastical Beasties when the kitten(s) is adopted on Adoption Day.

Once Fantastical Beasties receives the Adoption Questionnaire/Application, this Waitlist and Deposit Agreement, and the \$200 Waitlist Deposit per kitten pick/selection, a confirmation email/text will be sent confirming that you have been added to our Waitlist.
